This application allows the Indiana Gaming Company, LLC to contact the patron's financial institution to obtain non-public information, including average balance and current balance. The patron authorizes Indiana Gaming Company, LLC, or its affiliates, to verify information through any source, to obtain any credit related, gaming related or employment history information about the patron, to report any information to another casino or a credit reporting agency and to exchange any information with any of the affiliates of the Company. The patron understands that any information released will be held in the strictest confidence by the Indiana Gaming Company, LLC. All documents and reports generated will become the property of the Indiana Gaming Company, LLC, and will be used for credit purposes only.

The patron agrees that the Indiana Gaming Company, LLC will determine the number of days negotiable instruments will be held. The maximum any negotiable instrument will be held is thirty (30) calendar days. In the event of non-payment within the determined time limit, the patron authorizes Indiana Gaming Company, LLC to present the negotiable instrument to the Federal Reserve System for payment at the patron's financial institution.

The issuance of casino credit is solely for gaming purposes only. All of your play must be rated on the casino floor. Inactivity of twelve (12) months may cause the credit line to be suspended and/or canceled. Indiana Gaming Company, LLC may reduce or revoke a credit line without advance notice.

Should the Indiana Gaming Company, LLC commence legal action to collect any money owed, the patron will pay the Indiana Gaming Company, LLC's attorney fees and the cost of collection. The Indiana Gaming Company, LLC may, at any time, charge a service fee for any check returned unpaid. The credit limits may change at any time, with or without notice. This agreement and subsequent credit transactions shall be construed according to Indiana law; venue shall be in the courts of Dearborn County in the State of Indiana.

I acknowledge that Indiana Gaming Company, LLC may apply any chips, slot cash tickets, or jackpots presented by me to the redemption of any outstanding or returned markers.
